Panelist Biographies

Lawrence Montle

Lawrence Montle is the Chief Information Security Officer and Privacy Officer at the New York State Insurance Fund (NYSIF). He is responsible for the development and implementation of a comprehensive information security plan to improve and ensure agency security levels. In this role, Montle oversees the recommendation and design of targeted strategies and initiatives to effectively assess risks, maintain the security of NYSIF's proprietary data, and ensure its protection from unauthorized use.



His previous positions include internal audit director for the New York State Department of Financial Services and information technology director at the New York Liquidation Bureau. Montle holds certifications in information privacy (CIPP/US, CIPT, and PLS), fraud investigation (CFE) and information systems auditing (CISA), and is licensed to practice law in New York and Washington, D.C.

Montle received his M.B.A. in finance and management from Fordham University and his J.D. degree from New York Law School. He obtained his undergraduate degree from New York University.

Kahini Ranade

Kahini Ranade is an Assistant General Counsel and Agency Privacy Officer at the City of New York's Office of Technology & Innovation (OTI), where she negotiates and drafts contracts for technology purchases supporting municipal government and the services it provides 8.5 million New Yorkers.



Before joining OTI, Kahini worked at the Mayor's Office of Information Privacy under the leadership of the City's first Chief Privacy Officer. There, she advised 175+ agencies and offices on privacy



questions, drafted data sharing agreements supporting mayoral priorities like housing voucher distribution, and supported critical pandemic responses such as food distribution, vaccine center staffing, contact tracing, and in-home vaccination efforts as a member of the City's COVID-19 Vaccine Command Center. She has also completed legal fellowships at the New York City Housing Authority and Metro-North Railroad.

Kahini graduated from the University of Wisconsin Law School. She is licensed to practice law in New York.

Chad Rosenthal

Chad Rosenthal is the Director & Associate General Counsel for Privacy and Digital Platforms at LG Electronics USA, Inc., a position he has held since May 2022. In this role, he oversees all facets of privacy and cybersecurity law for LG's U.S. affiliates and provides legal support for LG's digital platforms. Chad is responsible for leading initiatives related to privacy and data security compliance, policy development, incident response, privacy by design, regulatory and policy advocacy, privacy and cyber litigation, and vendor management.



Before joining LG Electronics, Chad dedicated more than two decades to public service, culminating in roles as Deputy General Counsel and Managing Attorney for the New York City Cyber Command and the New York City Department of Information Technology & Telecommunications (DoITT). At the New York City Cyber Command (NYC3), he was chief counsel to the City's CISO. His responsibilities encompassed supporting risk and threat management, incident response, vendor management, privacy initiatives, and the development of legislation, policies and directives.

In his role at DoITT, Chad led a team of accomplished information technology attorneys,



focusing on intricate contracts for software, cloud services, systems integration, and application development for DoITT, Cyber Command, and various city agencies.

Throughout his extensive career, Chad played a pivotal role in negotiating technology contracts amounting to billions of dollars with industry giants. As the lead attorney, he spearheaded transactions for key public-facing City initiatives, including 311, 911, IDNYC, nyc.gov, LinkNYC, DEP's automated water meter readers, and the City's CoVid19 Contact Tracing initiative. His negotiations extended to contracts underpinning the City's critical IT infrastructure, covering a broad spectrum of government operations such as public safety, human services, education, and economic development.

Prior to these roles, Chad served as an Assistant Corporation Counsel at the New York City Law Department, specializing in civil defense litigation related to employment discrimination, labor law, and tort cases in state and federal courts. He also served as an attorney in the Office of Mayor Rudolph Giuliani.

Chad received his law degree from Fordham Law School. He is CIPP/US and ITIL certified. He is licensed to practice law in New York
